HEALTH INSURANCE AND SUMMER TRAVEL

Summer is upon us and that means it's travel time! Travel is about making memories, seeing new places or visiting old ones that hold a special place in your heart. Some of you might even venture out of the US and its territories. What happens if you get sick? Will Medicare or your health insurance be effective?

The most important thing to know for those of you who have Medicare, is overseas travel is typically not covered (with the exceptions of Puerto Rico, US Virgin Islands, Guam, Northern Mariana Islands and American Samoa where Medicare will cover part of the care you may need). We recommend that prior to departing from the US, you meet with a knowledgeable, licensed insurance agent to see if there is a travel insurance policy that meets your needs and can provide you with the best coverage based on your overseas travel destination.

If you don't have Medicare, make sure you read up on your health insurance policy and see what could or could not be covered. We recommend reaching out to your insurance provider to get a further understanding of what type of medical coverage you'll have overseas and make sure you ask about specific locations or risk-based activities that are excluded from coverage under your policy.

Are you flying solo on this trip or does your spouse get to come too? Either way, make sure that your friends and family know where you're going. It's so important to make sure that a few people know your detailed itinerary (provide them with travel dates, flight/train/boat numbers and times, travel companions ect...). A crisis can happen at any moment and providing this information to them will make it easier for them to help you from back home. Don't forget to contact Elder Advisors Law to make sure your Estate Plan documents are up-to-date and to see if any of your documents should be given to your decision makers before you leave.

Ultimately, make sure you have fun! We didn't write this to worry you. We just want our Maintenance Family to be prepared. Following these suggestions can potentially help alleviate some of that travel anxiety.

RECIPE

OF THE SEASON

REFRESHING PINEAPPLE SALSA

Serves: 2 ½ Cups
Prep/Total Time: 15min

INGREDIENTS:

- Whole pineapple
- 1 cup diced pineapple
- 1 cup diced peppers any combination of red, orange, yellow or green peppers
- 1 cup diced Roma tomatoes
- 1/3 cup chopped cilantro
- 1/4 cup minced onion
- 2-4 tbsp lime juice about 2 limes or use bottled lime juice
- Salt and Pepper
- Optional: 1 tbsp diced jalapenos

1. To make the pineapple bowl, cut about 1/3 of the pineapple off, leaving the stem attached to the larger piece of the pineapple. Make a cut around the outer edge of the pineapple fruit and make cuts across the middle too. Use a metal spoon to loosen and scoop out the pineapple chunks. Pour the extra juice out of the pineapple bowl so that it is empty.
2. Dice enough of the pineapple chunks to make one cup of diced pineapple to be used for the salsa and save the rest for another use.
3. In a small bowl, mix together diced pineapple, diced tomatoes, diced peppers, minced onions, chopped cilantro, lime juice, salt, and pepper.
4. Transfer the salsa to the pineapple bowl for serving.
5. Store in the fridge.



BECKY'S RECIPE PICK

Although it's not a family recipe, I chose to share this since it's become a summer must-have when we host or attend cookouts.

The flavor is so refreshing that it works as an appetizer with chips or as a topping on grilled chicken or tacos.
